Required Textbook: *Introductory Algebra, 9/e*, by Bittinger. This textbook can be purchased new bundled with MyMathLab (an online tutorial) at no extra charge. If you purchase a used textbook, MyMathLab can be purchased online at www.mymathlab.com for approximately \$42. MyMathLab is strongly recommended for supplemental use by my students.

Course Description: This course covers signed number arithmetic, square roots, order of operations and algebraic expressions. It also covers equation solving, factoring, graphs of linear equations and solving of equations.

You are required to attend class every day. After 4 hours of absence, you **may be dropped** from this class. It is **your responsibility** to keep your enrollment status current. **You risk an “F” if you stop attending without officially withdrawing.** Do not bring friends or children to class. **Please turn off any cell phones or pagers during class time (or switch them to silent mode).** No cell phones will be allowed on your desk during exams.

Homework Policy: Practice is essential. Homework will be assigned and collected daily. It will be graded upon effort, not correctness. Your lowest 3 HW scores will be dropped. Collectively, your HW category will count as one exam score.

Grading Policies: Grades will be based on all chapter tests, homework, and the final exam. No calculators, notes or “cheat sheets” will be allowed on any exam. Any exam not taken will be regarded as a zero. The lowest chapter exam score (including the HW, but not the final exam) will be deleted prior to computing the term grade. The final exam (which counts as **two** exams) is both required and comprehensive. Students are expected to complete all exams during class on the dates and times scheduled. **No make-up or re-take exams will be given.**

Grading Scale: A=90% or above; B=80%-89.9%; C=70%-79.9%; D=65%-69.9%; F=below 65%
