**Prerequisite:** Math 50 with a grade of "C" or better. **Be sure that you meet this requirement.**

**Textbook:** *Intermediate Algebra, 7th edition*, by Bittinger / Ellenbogen. This textbook can be purchased new bundled with MyMathLab (an online tutorial) at no extra charge. If you purchase a used textbook, MyMathLab can be purchased online at [www.mymathlab.com](http://www.mymathlab.com) for approximately \$57. **Course Description:** This course is designed to serve as preparation for the study of college algebra, statistics, trigonometry and other college mathematics courses. Topics include a review of the real number system, an introduction to imaginary and complex numbers, the solution of first degree, quadratic and systems of equations, polynomials, rational expressions, exponents and radicals, graphs of functions (both linear and nonlinear) and of relations, and exponential and logarithmic functions.

**You are required to attend class every day.** After 4 hours of absence, you **may be dropped** from this class. It is **your responsibility** to keep your enrollment status current. You risk an “F” if you stop attending without officially withdrawing. Do not bring friends or children to class. **Please turn off any cell phones or pagers during class time (or switch them to silent mode).** No cell phones or mp3 players will be allowed on your desk during exams.

**Homework Policy:** Practice is essential. Each student is expected to spend at least 2 hours doing homework for each hour this class meets. Homework will be checked on exam days while you are taking your exams. I expect you to practice *at least* every-other-odd exercise in your text (#1, 5, 9, 13, etc.) unless otherwise directed.

**Grading Policies:** Grades will be based on the 9 chapter exams (section 10.1 will be included on the chapter 9 exam), homework (the homework scores will collectively count as one exam score after the lowest chapter HW score is dropped) and a cumulative final exam which will count as two exams (and may not be dropped). The lowest chapter exam score (or collective homework score, if that is your choice) will be dropped before computing the term grade. No calculators, notes or “cheat sheets” will be allowed on the first eight exams. (Non-graphing calculators will be allowed on the Chapter 9 exam.) Any exam not taken will be regarded as a zero. Students are expected to complete all exams during class on the dates and times scheduled. **No make-up or re-take exams will be given.**

**Grading Scale:** A=90% or above;    B=80%-89.9%;    C=70%-79.9%;    D=65%-69.9%;    F=below 65%
